- No animals, with the exception of guide dogs, are permitted in the building
- No printed materials, including political material aimed at any person or party, may be distributed during the festival without prior approval by The Paloma Irish Arts Foundation Inc.
- The Marriott is a non-smoking Facility.
- Do not carry alcoholic beverages outside of the Marriott where these beverages are served. It is against the law to do so.
- The Marriott follows regulations established by the Pennsylvania Liquor Control Board. Proper ID must be presented upon request.
- Only authorized personnel are permitted on the Main Stage & Heritage Stage, behind these stages and on any scaffold.

- Flyers attached to the walls and/or costumes hung on railings, etc... are not allowed and will be removed. Dance Competitors wishing to advertise costumes for sale must hang the costumes in the appointed "Dress Room."
